### Solution:

The error is in the first part of the sentence.

Since amenable always takes the preposition 'to' after it. If a person or thing is amenable to something, they are ready, willing, or responsive. Therefore, 'amenable to' is the correct usage here. It means to be willing to.

### Solution:

The error is in the fourth part of the sentence.



After certain words (let, bid, between, but, except etc., when used as a preposition) pronouns are always used as objective case (object of the preposition). Therefore 'he' should be replaced with 'him'.

Note: Here 'present' has been used as an adjective providing the context of 'in a particular place'.

E.g. The whole family was present.

### Solution:

The error is in the second part of the sentence.

Since 'Both' should always be used with 'and'. Therefore, 'among' should be replaced with 'and' in the second part of the sentence to make the sentence grammatically correct. An alternative will be to remove 'both' to make the sentence correct.

### Solution:

The error is in the fourth part of the sentence.

There are a few adjectives (elder, prefer, preferable etc.) which always takes 'to' in comparative form rather than 'than'. Therefore, 'than' must be replaced with 'to' to make the sentence grammatically correct.

### Solution:

The error is in the third part of the sentence.

If either/or, or, nor, neither/nor connects one singular and one plural subject, then the verb that follows must agree with the subject that is nearest the verb. Therefore, 'is' should be replaced with 'are' to make the sentence grammatically correct.

The error is in the second part of the sentence.

Here 'students' is plural so the following singular verb 'has' must be replaced with plural verb 'have' to make the sentence grammatically correct.

Every service that Google provides is provided via its huge data centres, which consume vast amounts of electricity to power and cool the servers and are therefore responsible for the



emission of significant amounts of CO2. Since the advent of the modern smartphone in about 2007 our reliance on distant data centres has become total, because everything we do on our phones involves an interaction with the 'cloud' and therefore has a carbon footprint. The size of this footprint has been growing. At the moment, about 7% of the world's electricity consumption is taken by our digital ecosystem but this forecast is to rise to 12% by 2020 and is expected to grow annually at about 7% through to 2030.

The big internet companies are acutely aware of this. Electricity costs money and they are fanatical about reducing costs. And they are desperate to avoid the PR downsides of being perceived as energy hogs. So, they have responded to a challenge issued by the environmental group Greenpeace some years ago – to commit to having all their activities powered by renewable sources. Facebook, Apple and Google made this "100% renewable" commitment four years ago and have now been joined by nearly 20 other internet companies. The trouble is that server farms and networks account for only 50% of the electricity consumption of our networked world. The devices we use consume another 34% and the industry that manufactures them takes up the remaining 16%. Making environmental progress on these fronts will be much harder. A desktop PC running eight hours a day, for example, emits 175kg of CO2 in a year. So, you can imagine the carbon footprint of a large city office block that has thousands of desktop PCs running for the whole of a working day. Multiply that by all the office blocks in the centre of London and you get an idea of the environmental impact of even the humble PC.

### Solution:

Out of all the given options, option A is TRUE.

It is clearly stated in the passage that with the advent of smartphones, our dependency on the data centres has become total, thereby, has the carbon footprint.

Option B is false because the digital ecosystem consumes about 7% of the world's electricity currently.

Option C is false because 50% of the electricity consumption of the networked world is by server farms and networks and thus, is the highest consumer of the electricity.



Option D is false because the carbon footprint is expected to grow at about 7% annually.

#### Solution:

The author describes the amount of electricity consumed by the data centres and the ways which companies are opting to cut down the electricity cost. Therefore, the tone of the passage is informative which means 'providing useful or interesting information'.

'Satirical' means 'sarcastic, critical, and mocking another's weaknesses', 'optimistic' means 'hopeful and confident', 'sarcastic' means 'marked by or given to using irony in order to mock or convey contempt' and 'nostalgic' means 'feeling, evoking, or characterized by nostalgia'. All these tones do not aptly describe the tone of the given passage.

#### Solution:

It is clearly stated in the passage that every service provided by Google is provided via data centres which consume a lot of electricity and is therefore, responsible for emission of significant amount of CO2. Also, invention of modern smartphones has a carbon footprint.

However, mining of cryptocurrency as the cause of carbon footprint is nowhere mentioned in the passage.

Therefore, mining of cryptocurrency is not the probable cause of increase in carbon footprint.

Therefore, statement I is TRUE. It is mentioned in the passage that some of the big internet companies like Facebook, Apple, Google have made 100% renewable commitment to cut down the electricity cost. Therefore, statement II is also TRUE.

According to the Cambridge dictionary, 'Greenhouse gas' means 'a gas that causes the greenhouse effect, especially carbon dioxide'. So, statement III is also TRUE. Therefore, option E is the correct answer.

Hence, options other than 'accustomed' can be eliminated.

The error is in part B of the sentence. There is a spelling mistake. The correct spelling of the word is "hibernation".

The error is in part B of the sentence.

The word "uniform" has been incorrectly used here. Note that the word mentioned after "uniform" is "individual", which is a noun. So, we need an adjective to modify this noun.

Thus, "uniformed" should replace the highlighted word mentioned in B.

Note:'Supposed', the past participle form of the verb 'suppose', is acting an adjective in the sentence and is modifying the noun 'increase'

The error is in part C of the sentence. There is a spelling mistake. The correct spelling of the word is "regardless".
