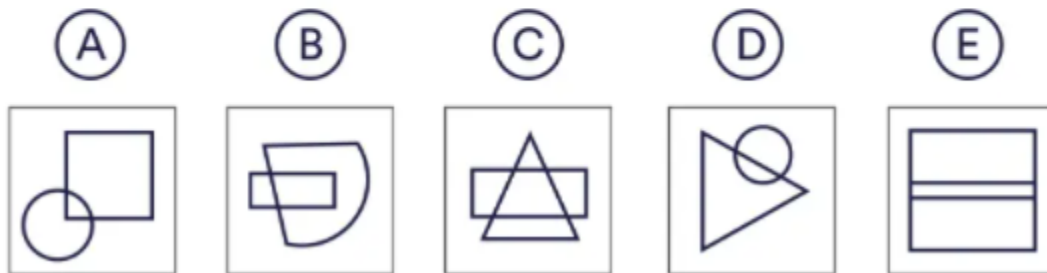

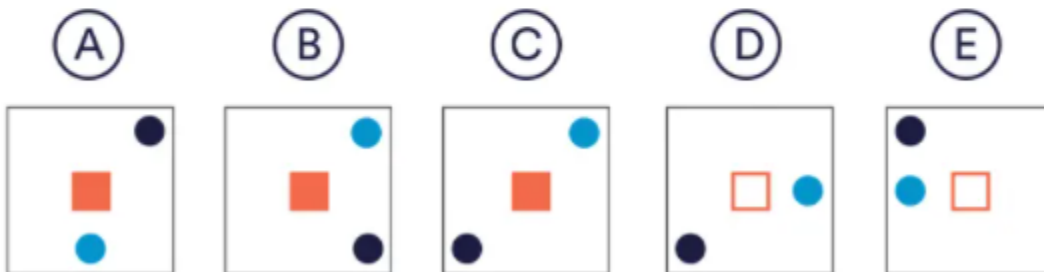

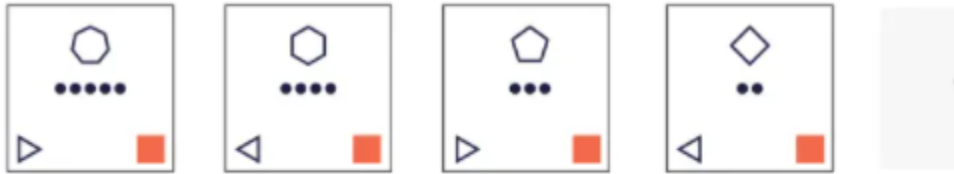

It also increases how many spaces it moves in increments of one. First, it moves anti-clockwise one position, next it moves 2 spaces clockwise, then 3 anti-clockwise, and so on.

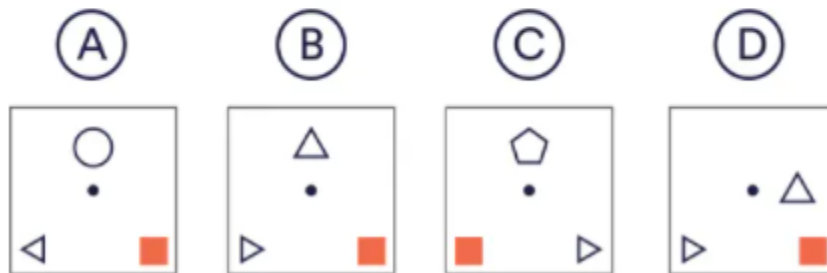
