Xavier General Management Aptitude Test (X-GMT) is an online entrance test being conducted by Xavier University Bhubaneswar (XUB) for admission into various Master's Degree Programs as follows:

- MBA in Business Management (MBA-BM)
- MBA in Human Resource Management (MBA-HRM)
- MBA in Rural Management (MBA-RM)
- MBA in Sustainability Management (MBA-SM)
- MBA in Urban Management & Governance (MBA-UMG)
- Master of Business Finance (MBF)
- Executive MBA in Business Management (EMBA-BM)
- Executive MBA in Business Analytics (EMBA-BA)

Eligibility for attempting X-GMT 2020 is a Bachelor's Degree or equivalent (of minimum 3-year duration) in any discipline from a recognized university with at least 55% of marks in aggregate. Candidates who expect to complete the final part of their degree examinations by June 15, 2020, can also apply.

Pattern of X-GMT 2020

- X-GMT 2020 will be a computer-based online test
- The duration of the exam will be 120 minutes & the medium of the test is English for all the candidates.
- Candidates need to attempt multiple choice questions (MCQs) that will be spread across 4 sections, namely, Quantitative Aptitude (QA), Verbal Ability & Logical Reasoning (VA & LR), Data Interpretation (DI), Emotional Quotient and General Awareness (EQ & GA).
- The four sections during the test will appear in random sequence and there will be sectional time limits, which means a candidate must complete a section in a given time. If a candidate finishes any section early, (s)he must wait for the next section to begin and can't go back to a completed section.
- The type and nature of questions will be like the other prominent entrance tests for management education.
- There will be negative marks for incorrect answers

X-GMT 2020 Exam Centers
