

ADVERTISEMENT FOR RECRUITMENT OF PARA LEGAL VOLUNTEERS (PLVs)

It is for general information that District Legal Services Authority, Chirang intends to induct 50 nos. of Para legal Volunteers (PLVs) for Chirang district. As such, applications in Standard Form are invited from intending candidates of the *following groups of people residing in Chirang district*:

Teachers (including retired teachers), Retired Govt. Servants and Senior Citizens, M.S.W. Students and teachers, Anganwadi Workers, Doctors/Physicians, Students & Law Students (till they enroll as lawyers), members of non-political, service oriented NGOs and Clubs, members of Women Neighbourhood Groups , Maithri Sanghams and other Self Help Groups including of marginalized/ vulnerable groups, educated prisoners with good behavior serving long term sentences in prisons.

The candidates should have **minimum qualification of matriculation** with a capacity for overall comprehension who do not look up to the income they derive from their services as PLVs and who have a mind-set to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of the marginalized and weaker sections of the society.

It needs to be mentioned herein that the work of PLVs does not carry any salary, remuneration or wages except honorarium fixed by the Assam State Legal Services Authority from time to time (at present Rs. 500/- per day). Further, reasonable travel expenses may be reimbursed to PLVs on production of proof. The duties, function and remuneration of PLVs shall be governed by NALSA Scheme for Para Legal Volunteers and regulations in this regard from time to time.

The candidates shall have to mention in their applications about their willingness or place of preference to work at either district-level or village-level.
