

IMPORTANT INFORMATION :


- The examinations (theory and practical) will be held as per the programme notified even if any of the Date is declared as holiday subsequently.
- Candidates are advised to enter the examination centre 30 minutes before the commencement of the examination in a sitting, and enter the examination room/hall before 15 minutes of examination to occupy their seats allotted to them.
- Before sitting, a candidate has to be ensuring that she/he has occupied the sit allotted to him.
- Distribution of answer books to the candidates will be made 10(Ten) minutes before the commencement of examination.
- Question papers will be distributed 05(Five) minutes before the commencement of examination.
- The candidates shall be under CC TV surveillance throughout the examination period.
- All compartmental candidates in vocational stream (registered upto 2015) are required to appear in all the subjects.**
- The Biology Examination (Regular/Ex-Regular) will be held in a single sitting. Biology (Section-A: Botany) examination will be held from 9.00A.m to 10.30 A.M, and Biology (Section-B: Zoology) examination will be held after a gap of 20 minutes, i.e. from 10.50 A.M. to 12.20 P.M.
- All Regular & Ex-Regular candidates (Arts/Science/ Commerce) registered up to 2020 will be give question papers printed on white paper.
- All Regular & Ex-Regular candidates (Vocational stream) registered up to 2020 will be given question papers printed on green paper.
- The questions shall come from the existing reduced syllabus.
- All examinations will be conducted following COVID appropriate behavior, and all personnel engaged in the examination process shall ensure this.
- Any omission and/or error detected should be brought to the notice of the controller of examinations immediately.
