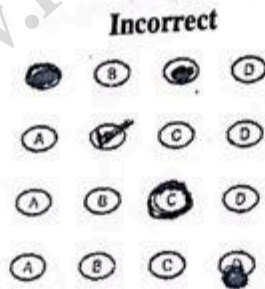
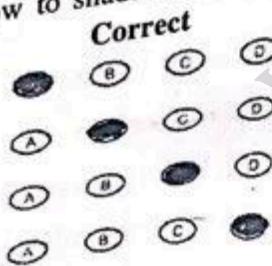


INSTRUCTIONS

1. Total number of questions is 100. Each question carries one mark. There is one-fourth negative marking for wrong answer i.e. -0.25.
2. On the OMR Response Sheet fill the Roll Number by shading circles. Also write Roll Number in figures and words at the appropriate space provided.
3. Ensure that Question Booklet is complete and contains questions in proper sequence.
4. Ensure that the 4 digit code no. on question booklet matches with the code no. on your answer sheet. In case of any discrepancy, inform the Centre Superintendent before attempting any question.
5. (a) There are four options (A), (B), (C) and (D) specified against each question. Out of these, only one is correct.
 (b) In the OMR sheet provided, there are four circles against each question marked (A), (B), (C) and (D).
 (c) One and only one of the four circles is to be fully shaded by the candidate for marking the correct response. Shading of more than one circle will be treated as wrong answer.

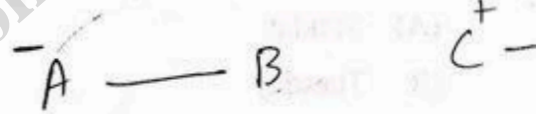
